BEALS/SHAHIN AWARDS COMMITTEE: Reviews entries by DCMS members of medical articles they have published in the past year to determine the winners of the annual John A. Beals' Awards, and articles written by physicians in training in Duval County to determine the winners of the annual G. Shahin Awards.

BIOTERRORISM, DISASTER RESPONSE & HOMELAND SECURITY COMMITTEE: Facilitates disseminating information and resources to Duval County physicians and their offices necessary to assist them in responding to natural, biological, chemical or nuclear disasters or pandemic emergencies in our area.

BYLAWS COMMITTEE: Reviews and recommends proposed changes to the DCMS Bylaws to the DCMS Board of Directors, who in turn, recommends the changes to the DCMS Members for ratification.

HEALTH INFORMATION TECHNOLOGY (HIT) COMMITTEE: Responsible for communicating and implementing strategies to educate DCMS members regarding the evolution and adoption of health technologies in order to generate efficiencies and improve quality patient care.

JOURNAL & COMMUNICATIONS COMMITTEE: Serves as the editorial board of *Northeast Florida Medicine* (the DCMS journal) and oversees the production of the *DCMS Directory*.

JUDICIAL COMMITTEE: Reviews and facilitates the settlement of misunderstandings and alleged misconduct complaints filed against DCMS members by their patients in hope of preventing the complaint to proceed to litigation or Board of Medicine review.

MEMBERSHIP COMMITTEE: Responsible for recruitment, follow-up and retention of members.

NORTHEAST FLORIDA LEGISLATIVE COMMITTEE: Responsible for evaluating and advising the DCMS on legislative issues and maintaining strong relationships with local legislative delegations.

SPORTS MEDICINE COMMITTEE: Coordinates annual health screenings for public middle and high school students in conjunction with the Jacksonville Sports Medicine Program (JSMP), as well as the Team Physician Program for high schools.
